- In the early days of IFMA a Chapter needed 10 members to charter. But again this continuing interest for starting a Chapter did not garner enough momentum to sustain that number. So the “Harrisburg” listing was a bit premature in the 1987 IFMA Membership Directory.

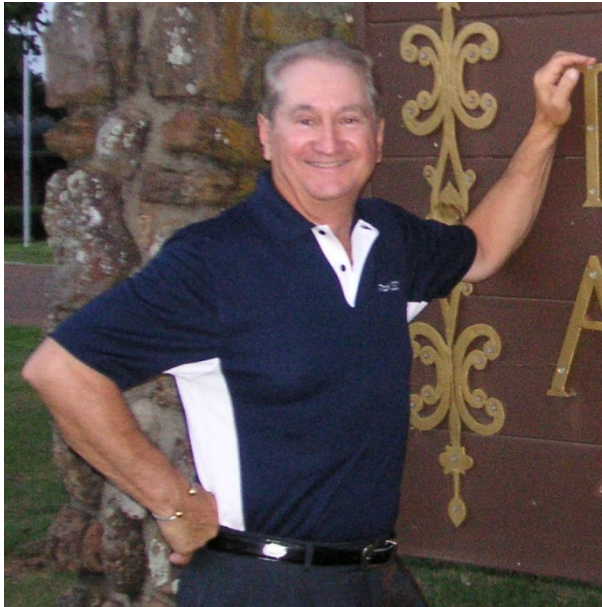

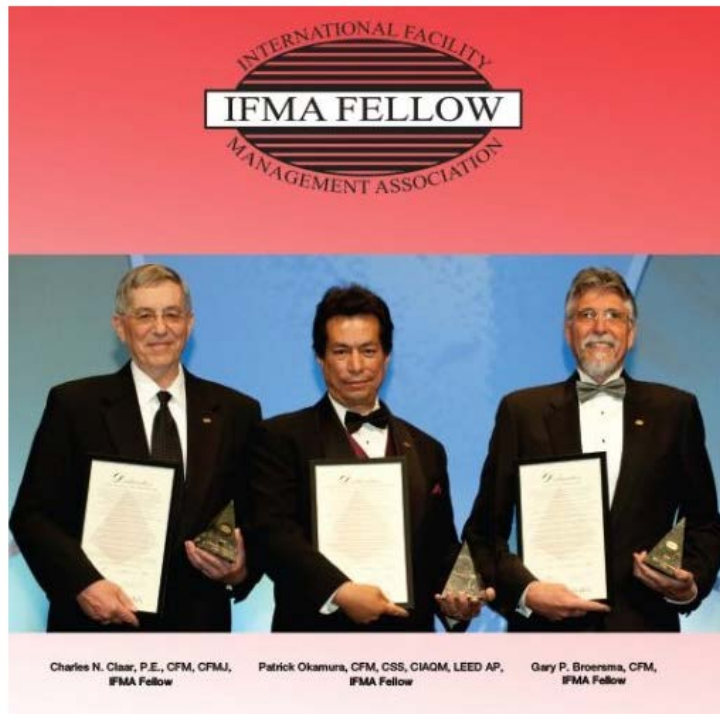


Mid-2000's Chapter Officers

- The Chapter Board submitted for recognition and received the 2013 Awards of Excellence – Small Chapter of the Year Award at World Workplace in Philadelphia.

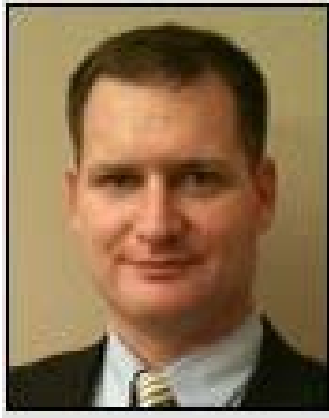
